### What is Institutional Compliance?

The Office of Institutional Compliance is responsible for coordinating compliance oversight, monitoring, and reporting. Although Institutional Compliance coordinates compliance efforts campus-wide, departments and individuals with compliance responsibilities are subject-matter experts in their respective areas and should continue to be your first contact for specific compliance questions. Chapman University is committed to conducting its affairs ethically and in compliance with governing laws, regulations, and policies.

Additionally, there is an **Institutional Compliance Committee** (ICC) made up of senior members of the Chapman community to help provide broad oversight of university-related regulatory issues.

#### What does the ICC do?

- Provides guidance and input on the development of a comprehensive compliance program.
- 2. Identifies and discusses compliance related topics that could affect the university.
- 3. Promotes compliance within the members' respective units and throughout the university.
- Aids in the identification of compliance risks where exposures may not be fully addressed.
- Assists in the identification of compliance-related educational needs.
- 6. Identifies policies and procedures that are needed to ensure regulatory requirements.
- 7. Develops, implements, and improves the compliance program within the members' respective units, based on best practices delineated in the U.S. Federal Sentencing Guidelines.
- 8. Encourages open communication among campus compliance units and senior university leadership.
