PHARMACY ADMINISTRATION AND MANAGEMENT III (PHCA 8301)

Fall (3 credit hours) – Course Coordinator 2013

This course exposes the student to key concepts in behavioral science theories needed to develop interventions to change health behavior. Students will become familiar with how behavioral science theories are used in health education and health promotion, identify theoretical constructs that they can use in planning health education and promotion interventions, and recognize the appropriate use of constructs in measurement and intervention.

PHARMACY MANAGEMENT I – (PHAR 4260) (Professional Year 1)

Spring (2 credit hours) - Course Coordinator 2014 - Present

Major legislation that has shaped the structure and financing of healthcare and opportunities for pharmacist will be reviewed.
