<u>Catalog Description</u>: Prerequisite: acceptance to the University Honors Program, or consent

of instructor and Honors Director. Elder Law concerns legal issues involving the rights and needs of older people. Finance and healthcare matters are central in the study of elder law but any issue which

impacts an elder's quality of life is included. In this course students will

study the various issues and laws which confront the elderly.

(Offered as needed) 3 credits.

Course Objectives: Elder Law is an introductory course in law for undergraduates who

desire to learn about the legal issues of the elderly and the laws

governing these issues. The focus of the course will be the legal issues and laws confronting the elderly with a consideration of the social and financial concerns underlying these issues and laws. Emphasis is given to how the law provides for the financial and health care challenges of the elderly. Students should acquire a fundamental understanding of elder law topics including wills, trusts, advance care directives, estate planning, capacity, elder abuse, medical decision making and age

discrimination in employment.
