- Hannah Welsh: Presented funding request for IES Inc., an event for IES students. Requested \$250 from the Senator line for food for the event from Sodexo.

c. Chabad Conference

- i. Hannah Welsh: Allocations reviewed Chabad's request for \$10,000 for airline tickets to a conference.
 - 1. Sarah Band: How many students will attend?
 - a. Josh Simkowitz: 20 students will attend.
 - 2. Mo Hijazi: Concerned about using \$10,000 for only 20 students. Could we fund only a portion and the students can fund the other portion of their tickets? \$10,000 is like an eighth of the budget.
 - 3. Talia Israel: We approved something similar to this for another religious organization.
 - a. Hannah Welsh: Yes, for CRU.
 - i. Brady Francisco: When did we do that?
 - 1. Hannah Welsh: 2 weeks ago.
 - ii. Mo Hijazi: Hannah can you get those numbers? That was for more than 20 people, like over 50. This is a larger request for a fewer amount of people.

- 4. Elyse Crimmins: \$750 is the max an organization can request per student, and this is under that. It's \$500, it's a reasonable request.
- 5. Hannah Welsh: CRU requested \$5,000.
- 6. Brady Francisco: What is the subject of the conference, what are the benefits for your organization to attend?
 - a. Josh Simkowitz: Pegisha is a conference in New York. You're asking the significance of spending \$10,000 to send 20 students. The Jewish population at Chapman is 10%. Spending money on these 20 students affects more than just those twenty. About 200 kids attend events weekly, they would be affected by this as well. Conference provides an opportunity for people to learn more about the Jewish identity, hear from famous speakers, and meet other Jewish people from college campuses around the country. When they return to their campuses from the conference they have the opportunity to become leaders for their peers and other Jewish students, become involved, and learn why it's important to be involved in our community. We learn why it's important to be involved in our Community and why it's important to embrace our Jewish identity. This is an experience unlike any other.
- 7. Philip Goodrich: We have a \$1.2 budget, my focus is to support students now, support student orgs now. Students should not pay for part of their flight if we can fund it in full.
 - a. Cristina Molina: I agree.
- 8. Hannah Welsh: Allocations made the recommendation to fund this in full.
- 9. Victoria Mas: Echoing Philip and Cristina, we should fund this.
 - a. Speaker: Agree, we have funded similar things, we need to support this.
