EXPERIENCE

Clinical Professor and Director, Constitutional Jurisprudence Clinic, Chapman University School of Law (2009 to present)

The Constitutional Jurisprudence Clinic focuses primarily on appellate level litigation in cases that raise issues of original meaning of the Constitution or other founding era principles of government and individual liberty. The clinic's work in representing the Center for Constitutional Jurisprudence was recently recognized by SCOTUSBlog. The Center was ranked the sixth most influential organization in the nation in urging Supreme Court review of cases. Further, the brief I authored in *Arizona v. Inter Tribal Council*, was cited by Justice Thomas in his dissenting opinion in the case.

The practice covers state and federal litigation at both the trial and appellate levels and includes business litigation, civil rights, and regulatory compliance.

This class is a general course on state constitutions, covering structure of state government and unique provisions of state charters. I created the course syllabus and supplemented a text book with additional cases to give the class a California focus.
